Welcome to the 2008-2009 school year! I will be your child's reading teacher this year. We will be utilizing the newly adopted Language! program during this school year. This is an exciting program and will benefit your child immensely. We will be focusing on the following academic areas:

- Strand 1: Reading Process
- Strand 2: Comprehending Literary Text
- Strand 3: Comprehending Informational Text

### **Tutoring and Cell Phones**

Tutoring times are available for all students. Due to the number of meetings I attend, tutoring times will be posted weekly on the board. Cell phones are allowed on campus; however, they can not be seen or heard during class time or they will be taken.

### **Homework and Planners**

I check planners on a weekly basis and grades will be written in them on Friday. Up to 100 participation points will be given each quarter based on use of the planner, preparedness for class and class participation.

### **Grading Policy**

Reading is a year long class. The class will include daily warm ups, Language! units, tests, and quizzes. Points will be converted to percentages and follow standard scale below.

- A = 100%-90%
- B = 89%-80%
- C = 79%-70%
- D = 69%-60%
- F = 59% and below

### **Late and Make-up work**

All assignments are to be handed in on time for maximum credit. Every day that an assignment is late, 20% will be deducted from the grade. Parents should request make-up work from the counselor's office as soon as it is known that a student will miss at least two days of school. It is the student's responsibility to get make-up and missed work from the teacher.

### **Testing Policy**

Tests are given at the end of each unit.
