You do not need to have a child enrolled in a school to take advantage of this state tax credit. *It is always best to consult a tax adviser to see if you qualify for the **dollar-for-dollar** credit.*

A tax credit is different from a deduction, because **you may subtract the Whole contribution** from your AZ state tax bill. An individual may contribute as much as \$200, and a couple filing jointly may contribute up to \$400 and receive **all the money back** in the form of a tax credit.
