**Purpose**

The Student and Parent/Guardian acknowledge that the Student was lawfully expelled from Mesa Public Schools for one or more violations of its guidelines for student behavior. The purpose of this Agreement is to set forth the terms and conditions by which the Mesa Public Schools Governing Board will readmit the Student. The Student must comply with all terms and conditions to remain enrolled in Mesa Public Schools. Failure of the Student to fully comply with the terms and conditions of this Agreement will result in the long suspension or expulsion of the Student.

**Terms and Conditions**

1. The Student and Parent/Guardian certify that all information provided by the Student and his or her Parent/Guardian with regard to the Student's request for readmission is accurate and complete.
2. The Student must:
  - attend classes regularly;
  - cooperate with all school personnel;
  - complete coursework assignments;
  - comply with applicable policies and regulations of Mesa Public Schools including, without limitation, the Information & Guidelines for secondary student behavior; and
  - not violate any criminal statute (other than a minor traffic safety violation) or the terms and conditions of any court order or court-supervised probation.
3. The Student must comply with the following additional terms and conditions: [If none, so indicate.] \_\_\_\_\_
4. The Parent/Guardian agrees to encourage and support the Student in meeting his or her responsibilities as a student.
5. Any violation of this Agreement by the Student may result in the long suspension or expulsion of the Student. The provisions in the District-wide Information & Guidelines for secondary student behavior regarding the range of disciplinary actions are hereby waived.
6. If a school principal or other administrator believes that the Student has violated this Agreement, the matter will proceed as a disciplinary matter, subject to a long suspension or an expulsion in accordance with Governing Board Policy JGD/JGE and its administrative regulations.
7. This Student Readmission Agreement represents the entire agreement between the parties with respect to the Student's readmission. This Agreement cannot be modified except through a writing signed by an authorized representative of Mesa Public Schools.
